#### COMMONWEALTH OF KENTUCKY COUNTY OF BULLITT ZONING ORDINANCE NO. 19-01

AN ORDINANCE RELATING TO THE CHANGING OF ZONING OF CERTAIN PROPERTY FROM R-3 RESIDENTIAL, R-4 RESIDENTIAL, AND AGRICULTURAL TO B-2 CENTRAL BUSINESS. THE PROPERTY IN QUESTION IS A PORTION OF THE 14.801 ACRES, MORE OR LESS, LOCATED ON RAYMOND ROAD, IN THE CITY OF SHEPHERDSVILLE AND AN UNINCORPORATED AREA OF THE COUNTY.

WHEREAS, the Fiscal Court of Bullitt County has considered the evidence of the public hearing held by the Planning Commission and the recommendations of the Commission; and

WHEREAS, the Fiscal Court concurs in and adopts the reasons of the Planning Commission for DENIAL of said zoning change and approves and accepts the recommendations of the Planning Commission in this matter as set out in said minutes; and

NOW, THEREFORE, BE IT ORDAINED BY THE FISCAL COURT OF COUNTY OF BULLITT, COMMONWEALTH OF KENTUCKY:

SECTION ONE: That the request to change the zoning for the above property located in the unincorporated area of Bullitt County and more particularly described in the minutes and records of the Planning Commission in Docket Number 2018Z-36 from R-3 Residential, R-4 Residential, and Agricultural to B-2 Central Business is DENIED.

<u>SECTION TWO:</u> This Ordinance shall take effect upon passage and publication.

SECTION THREE: Should any section, provision or part of this Ordinance be declared unconstitutional or invalid for any reason by a court of competent jurisdiction, then the remainder of this Ordinance shall not be affected and shall remain in full force and effect.
