AN ORDINANCE RELATING TO THE CHANGING OF ZONING OF CERTAIN PROPERTY FROM AGRICULTURAL TO R-4 RESIDENTIAL. THE PROPERTY IN QUESTION IS 1.50 ACRES, MORE OR LESS, LOCATED AT 1387 COLLINGS HILL ROAD, IN AN UNINCORPORATED AREA OF THE COUNTY.

WHEREAS, the Fiscal Court of Bullitt County has considered the evidence of the public hearing held by the Planning Commission and the recommendations of the Commission; and

WHEREAS, the Fiscal Court concurs in and adopts the reasons of the Planning Commission for said zoning change and approves and accepts the recommendations of the Planning Commission in this matter as set out in said minutes; and

NOW, THEREFORE, BE IT ORDAINED BY THE FISCAL COURT OF COUNTY OF BULLITT, COMMONWEALTH OF KENTUCKY:

<u>SECTION ONE:</u> That the above property located in the unincorporated area of Bullitt County and more particularly described in the minutes and records of the Planning Commission in Docket Number 2018Z-35 is hereby changed from Agricultural to R-4 Residential.

<u>SECTION TWO:</u> This Ordinance shall take effect upon passage and publication.

<u>SECTION THREE:</u> Should any section, provision or part of this Ordinance be declared unconstitutional or invalid for any reason by a court of competent jurisdiction, then the remainder of this Ordinance shall not be affected and shall remain in full force and effect.

He believes that the material that FEMA is requesting could be an issue and will come back to Fiscal Court in January with progress.

COLLINS HILL ROAD REPAIRS

Director Rouse spoke to Fiscal Court about the damage that was done to Collins Hill Road from a train wreck during the summer. He stated that CSX has agreed to blacktop a portion of the road that was damaged and will work with Mago Construction to have the work done.

Chief Financial Officer Keith Griffee presents the Year to Date Financials to Fiscal Court.

SPEAKER CHAPEZE LANE

Steven Phelps spoke to Fiscal Court about the City of Shepherdsville wanting to annexa portion of Chapeze Lane. He does not believe that the City of Shepherdsville can annex areas of the county with no approval from Fiscal Court. County Attorney John Wooldridge stated that the City is created by statute and is given powers by Legislature. The county does not have the power to intervene and if he believes something is being done illegally, they must take action through Circuit Court. Steven Phelps also wants to discuss how to establish Chapeze Lane as a Scenic By-Way. He has started the process in the past, but would like for it to be readdressed.

SPEAKER CHAPEZE LANE

William Kidd spoke to Fiscal Court about making Chapeze Lane a Scenic By-Way. He stated that there has been no progress made recently and would like to move forward with this project. Judge Roberts suggested that they get with Chief Financial Officer Keit h Griffee to reach a solution that they all will be happy with. This discussion will be placed on the next agenda for January 2, 2019.

SPEAKER CHAPEZE LANE

Frank Kramer spoke to Fiscal Court about the annexation of a portion of Chapeze Lane. He believes that the City of Shepherdsville is not following the law because they have nothing to annex too. County Attorney John Wooldridge stated that Fiscal Court is not a judicial body with the ability to interpret the law. They would have to take to action through Circuit Court.
