They are working very hard to make order out of chaos. He informed Fiscal Court that he will be able to give more details as they progress to seek out trends and link the crimes with data.

SPEAKER NEW ED QUICK ROAD

Wendy Geary spoke to Fiscal Court about the issues that arose over the weekend on her property on New Ed Quick Road. She stated that no one has ever asked for her permission to drive machinery on her 11 acres of land. She stated that her land is a mess and they had to rip the creek and backyard of her property because of dumping. She is asking the court what they can do to get it cleaned up and stated that the State and Federal Government have since taken over. County Attorney John Wooldridge stated that they are doing some research, but no one ever called their office. Discussion was had about miscommunication over this incident and that the proper authorities were not notified. Wendy stated that she wants communication over her land and what the remedy is to fix the problem. Judge Summers stated that they will give her contacts to the State to try to get some answers.

SPEAKER CLEAN UP DAYS PUBLISHERS BUILDING Frank Cramer spoke to Fiscal Court about his concerns over an individual holding a county position as well as a city officer. He believes that there is a conflict of interest. He also stated that he did not see any other bids for haul away containers for the Clean Up Days disposal. He called Waste Management and received a quote of \$515.00 to \$535.00 per container, which is cheaper that the original bid. He also questioned the court about records from dumpsters of steel being taken to Amen's in exchange for money.

Frank Cramer believes that the old Publishers building would be a prime spot for entertainment in the area. It could be used as a venue to attract people to Bullitt County.

ANNOUNCEMENTS

Judge Summers informed Fiscal Court that they will be having an unveiling of the new ambulance that is dedicated to the Armed Forces on Thursday, April 18 at 1:00 PM at the VFW Post in Shepherdsville.

Judge Summers also informed the court about the passing of his dear friend, Tom Kelley. He stated that he helped start CASA in the area and was a great man and friend.
