SPEAKER DRAINAGE

William Kidd spoke to Fiscal Court regarding the drainage issues within the County. He is happy about the growth, but there are issue arising on Beech Grove Road and Cedar Grove Road with the warehouses and water drainage issues. Judge Summers stated that they have recently hired an engineer to help the County moving forward and they are aware of the issues at hand.



SPEAKER ZONING 245

Herb Hibbs spoke to the Court regarding warehouses being built on Highway 245. He is concerned about the traffic by Bernheim Middle School and does not believe a warehouse in that location is a good fit for the area.

Discussion was had amongst members of the Court. Magistrate Logsdon stated that he was surprised to hear of the Warehouse on the Tourism Corridor. He stated that this location is in the City and the County does not have any rights to vote or oppose this. Judge Summers stated that if they had not made that area part of the Tourism Corridor then the warehouse would have been a million square feet, instead of the 400,000 square feet allowed.

SPEAKER ZONING

Larey Correll is a resident off Highway 245 and is opposed to the new warehouse. He stated that all of his neighbors and friends are opposed to a warehouse being in this beautiful area.

SPEAKER ZONING WAREHOUSES

Denise Perkins, a resident off of Plenmar Drive, spoke in opposition of the new warehouse off of Highway 245. She is concerned about the traffic in the area. She is a former bus driver and is aware of the dangers in the area and how frustrating it can be. Judge Summers stated that the county is next in line with the State to have all the traffic issues addressed. The six mayors in the county as well as the Court are going to Frankfort to ensure the County gets this funding. Magistrate Rayhill stated that the City cannot annex your land without your approval, so perhaps the family will do something different with the property.

SPEAKER WAREHOUSES

Randall Scott, a resident of Chapeze Lane, understands that the warehouse is not the responsibility of the Court since it is City property, but would like for a Constable or Deputy to direct traffic when school is in session.

SPEAKER ZONING AUDIT

Brian Bleemel stated that he is opposed to any new development that would add additional traffic to the area. He would like to see a Deputy present for traffic. Sheriff Sholar stated that they only have four deputies at a time to cover 300,000 square miles, and sometimes all officers are on the same call. He does not have the man power to cover it, but the Sheriff's Office does have a Reserve Deputy Program that volunteers can enter. Brian Bleemel stated that he is opposed to all of this annexing. He also brought up the issue of the Bullitt County Fiscal Court audit that was done. He questioned why the Audit stated that hourly employees actual time worked did not reflect on their time cards. Judge Summers stated that the

issue was resolved with the new employee handbook that the County has recently implemented.

SPEAKER ZONING TRAFFIC

Tammy Bleemel wanted to inform the Court about the traffic issues in the County. She has seen the change and growth within the County. She has seen Shepherdsville shut down when there are wrecks on Interstate 65, and students stuck on buses for hours that are also overcrowded. She wants the Court to focus on the infrastructure in the County with all the growth that will also continue to increase. Discussion was had amongst members of the Court.

SPEAKER TOURISM COORIDOR

Lucille Beckner spoke to the Court about her opposition for the warehouse. She would like to see the Bourbon Industry get together and fund a tourist attraction right next to the fairgrounds.

ANNOUNCEMENTS

Magistrate Logsdon wanted to recognize the Bullitt East Lady Chargers as the second in the State for basketball. They were awarded State Champion Runner Ups. He also congratulated Bullitt Central for winning the State Archery Championship.

Magistrate Rayhill thanked everyone for coming and telling the Court their needs and concerns.

Judge Summers wanted the Court to remember the life of Dash, the K9 Deputy Dog that lost his life on duty with the Shepherdsville Police Department. Faith Portman also announced that there will be a Memorial for Dash on March 27th and the community has done amazing with support and donations.

Sheriff Sholar wanted to commend the hard work of the Sheriff's Office, Shepherdsville Police, Kentucky State Police, Mt Washington Police, and Lebanon Junction Police, on the night that K9 Deputy Dog, Dash, lost his life.

EXECUTIVE SESSION CONVENED

On motion of Judge Summers, seconded by Esq. Mitchell, with Fiscal Court having concurred, the regular session stood in recess at 11:04 a.m. and an executive session was convened concerning real property acquisition pursuant to KRS 61.810(1) (b); in addition Fiscal Court Members, they may call specific individuals into this session, and is entitled to have the County Attorney present. Vote: Unanimous for – motion carried.

On motion of Judge Summers, seconded by Esq. Mitchell, stating no action was taken at this time; the regular session reconvened at 11:11 a.m.
