Chuck Price wanted to pass on a thank you from the Judge in Dawson Springs for our assistance in the community when they really needed it. He handed out maps from that area that saved many people's lives that day after the tornado. He would like to see our county get something like that in case of an emergency. He also wanted the court to be aware of the state of the roads in our county. He stated that we have the dirtiest roads in the state and it becomes a hazard when it rains and that dirt turns into mud. Judge Summers stated that they have been working on this matter with the dump trucks damaging and dirtying the road ways.

SPEAKER SURPLUS PROPERTY

Greg Younger is interested on purchasing the land that is tied to his property off of Collings Hill Road by the land fill. He stated that he wants to give his daughter some land to build on and wanted to start this process. County Attorney Rob Flaherty stated there is a lengthy process consisting of Fiscal Court to find the property is not in the interest of the county, having it surplused, and then put out for bid. Magistrate Rayhill suggested they have a sit down meeting with the Judge to get the logistics of the land and to discuss further.

SPEAKER ROADWAYS

Billy Shepherd stated the county is focusing their money on the Highway 44 between Shepherdsville and Mount Washington, but Highway 44 West is being neglected as well. He stated that it is in bad shape and there is land sinking by the VFW Post and the potholes are unbearable. He would like to see the Court reach out to the State Representatives on this issue.

#### **ANNOUNCEMENTS**

Magistrate Rayhill stated that most of the roads in our county are in nice condition, but the State Road portions are the hardest thing to get taken care of. He is proud to have the Road Department here in Bullitt County working so hard with the cities in the county to maintain this county together as one

Magistrate Logsdon stated that he believes the hardest thing is getting things moving in the right direction. As a Magistrate you cannot have the solution for every problem, but can get in contact with someone who can. Magistrate Mitchell stated that the Court has a beautiful working relationship and thanked this Court for their hard work and dedication to the County.

Judge Summers stated that the Court has been to Frankfort on several occasions with different members of the County and Cities to work on these road issues. He stated that when this Court was elected in, there was no working projects, and they have rectified that to have many projects going on simultaneously. He stated that the members of the Court do not always agree unanimously, but their interest is always in the best interest of the county.
