Judge Summers called the meeting to order at 9:30 a.m. and welcomed everyone. All magistrates were present. Chaplain Joe Wells gave the invocation and led the pledge to the flag.

FISCAL COURT BILLS APPROVED

Open Invoice Reports from the Judge/Executive's Office dated through August 2, 2022 had been submitted for Fiscal Court's review and approval and copies are on file in the County Clerk's Office. Disbursements from each fund totaled: #01-\$282,833.64; #02-\$210,811.14; #03-\$23,964.34; #09-\$31,358.25; #77- \$39,733.99. Grand total disbursements from all funds: \$588,701.36.

On motion of Esq. Mitchell, seconded by Esq. Logsdon, with Fiscal Court having concurred, the claims referenced above totaling \$588,701.36 were approved as presented and were ordered to be paid. Vote: Unanimous for-motion carried.

MINUTES APPROVED

On motion of Esq. Rayhill, seconded by Esq. Logsdon, and Fiscal Court having agreed to dispense with the formal reading, the minutes of the regular session of Bullitt County Fiscal Court held on Tuesday, July 19, 2022, were approved as presented and the Judge was authorized to sign same.

Sheriff Sholar introduced Alex Payne as the new Chief Deputy at the Bullitt County Sheriff's Office. Deputy Payne thanked the Court for this opportunity.

property in question is 5.9 acres, more or less, located at 250 Phelps Lane, in an unincorporated area of the county.

The Planning Commission recommended that the zoning change be approved based upon the fact that the requested zoning change is in agreement with the adopted Comprehensive Plan.

County Attorney, Robert Flaherty, gave the first reading, in summary, of Ordinance #22-14 for the record, and a copy is on file at the County Clerk's Office.

Attorney Emily Vessels, of Dinsmore & Shohl LLP, spoke in favor of this zoning request. This property is in a portion of the city and in a portion of the county. Ms. Vessels stated that single family homes, on Phelps Road off of Blue Lick Road, would be developed in the city portion of the property only. It is determined that there are no plans for the county portion of the property, but the entire tract must be rezoned either way. Discussion was had amongst members of the Court regarding access to the new development.

County Attorney, Robert Flaherty, gave the first reading, in summary, of Ordinance #22-17 for the record, and a copy is on file at the County Clerk's Office.

Attorney Eric Farris, representing the property owners and Core 5 Industrial Partner, spoke in favor of this zoning request as well as Zoning Ordinance 22-18. He stated that Core 5 will maintain the Scenic Corridor with landscaping restrictions, such as a high tree line and a berm as a buffer. Discussion was had amongst members of the Court and representatives from Core 5 Industrial Partners regarding the time line and finalized plans.

Lucille Beck, resident of Chapeze Lane, spoke against this zoning ordinance, as well as Zoning Ordinance 22-18. She stated that warehouses are an eye sore to the community, and is concerned about the impact it will have on our environment.

The Planning Commission recommended that the zoning change be approved based upon the fact that the requested zoning change is in agreement with the adopted Comprehensive Plan.

County Attorney, Robert Flaherty, gave the first reading, in summary, of Ordinance #22-18 for the record, and a copy is on file at the County Clerk's Office.

Attorney Eric Farris, representing the property owners and Core 5 Industrial Partner, spoke in favor of this zoning request as well as Zoning Ordinance 22-17. He stated that Core 5 will maintain the Scenic Corridor with landscaping restrictions, such as a high tree line and a berm as a buffer.

Lucille Beck, resident of Chapeze Lane, spoke against this zoning ordinance, as well as Zoning Ordinance 22-17. She stated that warehouses are an eye sore to a community, and is concerned about the impact it will have on our environment.

Robin Gehlbach spoke against this zoning request. She stated that conservation is being turned into concrete parking lots. She asked the court to care about the community and stop worrying about the dollar bill.

The second reading will be held on August 16, 2022.

COMMONWEALTH OF KENTUCKY COUNTY OF BULLITT ORDINANCE NO. 22-13

AN ORDINANCE AMENDING ORDINANCE 14-11 AND RELATING TO AUTHORIZING THE SALE OF MALT BEVERAGES, WINE, AND DISTILLED SPIRITS BY THE DRINK AND PACKAGE, THE SAMPLING OF WINE AT ANY LICENSED KENTUCKY SMALL FARM WINERY, AND THE SAMPLING OF DISTILLED SPIRITS AT ANY LICENSED KENTUCKY DISTILLERY ON SUNDAYS IN BULLITT COUNTY, KENTUCKY.

WHEREAS, KRS 244.290(4) authorizes a Fiscal Court to allow for Sunday sales of distilled spirits and wine at retail by authorized licensees; and

WHEREAS, KRS 244.480(4) authorizes a Fiscal Court to allow for Sunday sales of malt beverages by authorized licensees; and

WHEREAS, KRS 243.155 allows licensed small farm wineries to sell wine that they have bottled or that have been bottled by another small farm winery and to serve complimentary samples of wine that they have produced; and

WHEREAS, KRS 243.0305 allows for providing of samples and sales of private selection and souvenir packages by distilleries that have obtained a souvenir retail liquor license; and

WHEREAS, Fiscal Courts in Kentucky are authorized to enact legislation to promote and support the local tourism industry;

NOW, THEREFORE, BE IT ORDAINED BY THE FISCAL COURT OF COUNTY OF BULLITT, COMMONWEALTH OF KENTUCKY:

SECTION ONE: SALE AND SAMPLES OF DISTILLED SPIRITS, WINE, AND MALT

BEVERAGES BY THE DRINK AND PACKAGE

Any premises licensed to sell distilled spirits, wine, or malt beverages by the drink

or by the package may do so in accordance with the laws of the Commonwealth

of Kentucky.

B. Any premises licensed to serve complimentary samples of distilled spirits, wine, or

malt beverages may do so in accordance with the laws of the Commonwealth of

Kentucky.

C. For Monday through Saturday of each week, the sales referenced in subsection A

and the samples referenced in subsection B shall be limited, if at all, only by

Kentucky Revised Statute or regulation of the Department for Alcoholic Beverage

Control.

D. For Sunday, the sales referenced in subsection A and the samples referenced in

subsection B shall take place only from 10 a.m. until 11 p.m.

SECTION TWO: SEVERABILITY

Should any section, provision or part of this Ordinance be declared unconstitutional or

invalid for any reason by a court of competent jurisdiction, then such section, provision or

part shall be deemed separate, distinct and independent and the remainder of this

Ordinance shall not be affected and shall remain in full force and effect.

SECTION THREE: INCONSISTENT ORDINANCES REPEALED

All ordinances and resolutions. or parts thereof, to the extent they are inconsistent

herewith, are hereby repealed.

WHEREAS, the County of Bullitt has considered an Amendment to the Interlocal Agreement creating the Bluegrass and Central Kentucky Unified Police Protection System (BACKUPPS);

WHEREAS, KRS 65.240 requires the authorization of an interlocal agreement to be memorialized by ordinance or resolution;

NOW THEREFORE, be it Resolved by the County of Bullitt:

Section 1. That the Amendment to the Interlocal Agreement creating the Bluegrass and Central Kentucky Unified Police Protection System (BACKUPPS) is hereby approved in substantially the same form as the attached Agreement.

Section 2. That the County of Bullitt specifically agrees to abide by the Model Standard Operating procedures adopted by the BACKUPPS Board unless the Board authorizes the County to utilize different SOPs.

Section 3. That the Judge Executive is authorized to execute the Interlocal Agreement, acknowledgment of Model SOPs and any relevant documents on behalf of the County.

SPEAKER INDUSTRIAL REZONING GUIDELINES

Gary Board asked the Court to help the Planning Commission set guidelines for industrial rezoning cases. He believes we need more regulations for such developments in the County. He stated that the comprehensive plan needs to be updated and we do not need more warehouses here in Bullitt County. Judge Summers stated that they are reorganizing Planning and Zoning and Code Enforcement as well as restrictions, such as maximum height of buildings and landscaping.

SPEAKER MARYVILLE POOL

Amber Thompson asked the Court when Maryville Pool will be open. Judge Summers stated that the County received a bid from Aquatic Center in the amount of \$740,000.00 to revamp the entire park. He stated that it will be year 2024, before the process will be completed, due to extensive work that has to be done.

Robin Gehlbach thanked the Court and Fire Departments in the County. She asked the Judge if there was an update on Fiber Optic in the County. Judge Summers stated that there is no update at this time. Robin asked about the number of employees at McKesson, and informed the Court that they are requiring their employees get the vaccine.

ANNOUNCEMENTS

Magistrate Logsdon asked everyone to keep Eastern Kentucky in their prayers from the flooding. He also asked the Judge if there was an update on the Bogard Lane traffic light, and the Judge stated that the State plans to start it next.

Magistrate Mitchell also asked everyone to keep Eastern Kentucky in their thoughts and prayers.

Sheriff Sholar stated that Eastern Kentucky lost six police cruisers.

Judge Summers stated that CASA is doing a fundraiser at Paroquet Springs Conference Center on August 16, 2022. He stated that Emergency Management Services, Mayor Taylor, and Mayor Eadens, are putting together a trailer to fill up to send to Eastern Kentucky.
