**AN ORDINANCE AMENDING ORDINANCE 14-11 AND RELATING TO AUTHORIZING THE SALE OF MALT BEVERAGES, WINE, AND DISTILLED SPIRITS BY THE DRINK AND PACKAGE, THE SAMPLING OF WINE AT ANY LICENSED KENTUCKY SMALL FARM WINERY, AND THE SAMPLING OF DISTILLED SPIRITS AT ANY LICENSED KENTUCKY DISTILLERY ON SUNDAYS IN BULLITT COUNTY, KENTUCKY.**

**WHEREAS**, KRS 244.290(4) authorizes a Fiscal Court to allow for Sunday sales of distilled spirits and wine at retail by authorized licensees; and

**WHEREAS**, KRS 244.480(4) authorizes a Fiscal Court to allow for Sunday sales of malt beverages by authorized licensees; and

**WHEREAS**, KRS 243.155 allows licensed small farm wineries to sell wine that they have bottled or that have been bottled by another small farm winery and to serve complimentary samples of wine that they have produced; and

**WHEREAS**, KRS 243.0305 allows for providing of samples and sales of private selection and souvenir packages by distilleries that have obtained a souvenir retail liquor license; and

**WHEREAS**, Fiscal Courts in Kentucky are authorized to enact legislation to promote and support the local tourism industry;

NOW, THEREFORE, BE IT ORDAINED BY THE FISCAL COURT OF COUNTY  
OF BULLITT, COMMONWEALTH OF KENTUCKY:

SECTION ONE: SALE AND SAMPLES OF DISTILLED SPIRITS, WINE, AND MALT  
BEVERAGES BY THE DRINK AND PACKAGE

- A. Any premises licensed to sell distilled spirits, wine, or malt beverages by the drink or by the package may do so in accordance with the laws of the Commonwealth of Kentucky.
- B. Any premises licensed to serve complimentary samples of distilled spirits, wine, or malt beverages may do so in accordance with the laws of the Commonwealth of Kentucky.
- C. For Monday through Saturday of each week, the sales referenced in subsection A and the samples referenced in subsection B shall be limited, if at all, only by Kentucky Revised Statute or regulation of the Department for Alcoholic Beverage Control.
- D. For Sunday, the sales referenced in subsection A and the samples referenced in subsection B shall take place only from 10 a.m. until 11 p.m.

SECTION TWO: SEVERABILITY

Should any section, provision or part of this Ordinance be declared unconstitutional or invalid for any reason by a court of competent jurisdiction, then such section, provision or part shall be deemed separate, distinct and independent and the remainder of this Ordinance shall not be affected and shall remain in full force and effect.

SECTION THREE: INCONSISTENT ORDINANCES REPEALED

All ordinances and resolutions, or parts thereof, to the extent they are inconsistent herewith, are hereby repealed.

THIS ORDINANCE SHALL TAKE EFFECT UPON PASSAGE AND PUBLICATION AS  
REQUIRED BY LAW.

POLICE OFFICER AWARENESS

Darrell McHargue spoke with Fiscal Court about the lack of police presence in the middle of the night. He stated that more laws are broken and more crimes happen in the darkness and wants to know where all of the officers are. Judge Summers stated that there are patrols out in the County, but they also assist the cities when they can. They have a lot of square mileage to cover in the unincorporated areas of the county. Sheriff Sholar stated that there are four deputies out at any given shift that covers over 300 square miles of coverage. He suggested you go to the cities as well to heighten their number of officers as well. County Attorney Rob Flaherty stated that over 5,000 traffic violations have been ran in Bullitt County this year through all of the agencies. Magistrate Logsdon stated that everyone is working to increase their numbers, and working to remedy that window of crimes. He suggested also looking into Neighborhood Watches as well.

Robin Gehlbach addressed Magistrate Rayhill about the Zoning meeting he missed on the previous Thursday. She wanted to know why he is not present at those meetings to answer the public's questions. County Attorney Rob Flaherty stated that Magistrates are not allowed to go to the Property of Adjustment Meetings due to the exposure of the cases. They cannot view the notes, opposition, and information before it is brought before the Court.

LOWERING SPEED LIMIT

Rhonda Keeling stated that she lives across from the new Amazon Building and is asking the Court for help lowering the speed limit to 45 M.P.H. She stated that there are already wrecks in the area with the large trucks for shipping and receiving, and they are now expanding the road into her yard. The members of the Court stated that they are going to send in a proposal to Frankfort, attention to Matt Bullock, to help the situation. That is a State Road, but the County will prepare an official request.

On motion of Esq. Rayhill, seconded by Esq. Logsdon, with Fiscal Court having concurred, to have the County Attorney draw up a Resolution to send to Kentucky State Transportation to lower the speed limit to 45 M.P.H. from Salt River Bridge to Highway 245.

ANNOUNCEMENTS

Magistrate Mitchell stated that citizens in the county, that do not have running water, can reach out to the Bullitt County Health Department and Louisville Water to get added to the lines for a reduced price. He also asked Sheriff Sholar if they have any ideas for the Opium Settlement if Bullitt County gets any of the funds. Sheriff Sholar stated that there has not been much detailed information given, but the idea of a Long Term Rehab Facility has pros and cons. He stated that you cannot force people to go and get help, they have to want it themselves. He stated that the Sheriff's Office has a great relationship with the Robert Alexander Center for Recovery in Mt. Washington, and can help citizens who reach out with

the need. He stated he would ultimately like to get more canine dogs, more patrols officers, and investigators to assist with the drug problem in Bullitt County.

Magistrate Logsdon informed the Court that there will be a car cruise this weekend of August 20, 2022 for the Bullitt County Special Olympics. There will be another cruise on September 17, 2022 to support Morgan's Mission for Overdose Awareness. He encouraged everyone to be aware of your surroundings and be conscious of the drug problem within our area.

Judge Summers thanked Felicia Harper for all of her hard work in Planning and Zoning and wished her success being the new Head of Economic Development at KIPDA.


