MINUTES APPROVED

On motion of Esq. Rayhill, seconded by Esq. Logsdon, and Fiscal Court having agreed to dispense with the formal reading, the minutes of the regular session of Bullitt County Fiscal Court held on Tuesday, September 20, 2022, were approved as presented and the Judge was authorized to sign same.

ZONING ORDINANCE: FIRST READING ORDINANCE #22-22

A zoning ordinance for property owned by Carmel Bleemel, has been advertised for first reading and public hearing at this meeting. Planning and Zoning's Angie Finn gave the following overview of the Planning Commission's hearing and recommendation on Docket #2022Z-56:

➤ Ordinance #22-22; Docket #2022Z-56; Carmel Bleemel—an ordinance changing the zoning from Agricultural to R-1 Single Family Residential. The property in question is 3 acres, more or less, located at 550 Bogard Lane, in an unincorporated area of the county.

that the requested zoning change is in agreement with the adopted Comprehensive Plan.

County Attorney, Robert Flaherty, gave the first reading, in summary, of Ordinance #22-22 for the record, and a copy is on file at the County Clerk's Office.

ZONING ORDINANCE: FIRST READING ORDINANCE #22-23

Attorney John Wooldridge, representing Mark Stout and Stout Brothers Farm, Inc., asked the Court to push back the first reading, due to the property owners not being able to be present due to work obligations in another state. Discussion was had amongst members of the Court, County Attorney Rob Flaherty, and the constituents that were present that were planning on speaking against this Zoning Ordinance. County Attorney Rob Flaherty stated that it is up to the Court since it will be within the 90 day timeframe, but there could be an issue with due process if they only hear one side today since the property owners are not present to give a rebuttal or answer questions regarding the zoning change. There was more discussion regarding the best possible solution to hear both sides and the ability to ask questions.

On motion of Esq. Logsdon, seconded by Esq. Mitchell, with Fiscal Court having concurred, to postpone the first reading of Zoning Ordinance 22-23, Mark Stout and Stout Brothers Farm, Inc., until the November 1, 2022 meeting, so all parties can be present for the reading.
