He resides off Chapeze Lane and there are several spots that flood over the road that requires it to be shut down for several hours until it recedes. It creates a safety issue in the area when first responders and residents cannot get through. The county needs to sit down and plan for this drainage problem to find a solution.

SPEAKER NICHOLS FIRE BOARD

Mike Mabry of Nichols Fire Board spoke to the Court regarding the need for a new fire truck. He sent a proposal to the Court asking for \$500,000.00 to purchase new equipment for the County. Judge Summers stated that he has looked into this and stated that they do not have the ARPA funding available for this purchase. The money has already been committed to other projects throughout the County at this time.
