#### COMMONWEALTH OF KENTUCKY COUNTY OF BULLITT ORDINANCE NO. 23-11

AN ORDINANCE OF BULLITT COUNTY, KENTUCKY, AMENDING THE FLOOD DAMAGE PREVENTION ORDINANCE 16-05.

WHEREAS, the Bullitt County Fiscal Court in Bullitt County, Kentucky had previously established a Flood Damage Prevention Ordinance within Bullitt County, and

WHEREAS, all ordinances and part of ordinances in conflict herewith, to the extent of such conflict only, are hereby repealed, and

WHEREAS, this ordinance shall be in full force and effect from and after its adoption, readoption, and publication as required by law;

**NOW, THEREFORE, BE IT ORDAINED** by the Fiscal Court of Bullitt County that the Flood Damage Prevention Ordinance for Bullitt County be amended as follows:

#### ARTICLE 3. GENERAL PROVISIONS

## SECTION B. BASIS FOR ESTABLISHING THE SPECIAL FLOOD HAZARD AREAS

The areas of special flood hazard identified by the Federal Emergency Management Agency (FEMA) in the Flood Insurance Study (FIS) for Bullitt County, dated April 5, 2016 with the accompanying Flood Insurance Rate Maps (FIRMS), other supporting data, and any subsequent amendments thereto, are hereby adopted by reference and declared to be a part of these regulations. This FIS and attendant mapping is the minimum area of applicability of this ordinance and may be supplemented by studies for other areas which allow implementation of this ordinance and which are recommended to the Fiscal Court by the Floodplain Administrator and are enacted by Fiscal Court pursuant to statutes governing land use management regulations. The FIS and/or FIRM are permanent records of Bullitt County\_and are on file and available for review by the public during regular business hours at the Bullitt County Planning and Zoning Office located at 149 N. Walnut Street, Third Floor, Shepherdsville, Kentucky 40165.

Should any section, clause, line, paragraph, or part of this Ordinance be held unconstitutional or invalid for any reason, the same shall not affect the remainder of this Ordinance.
