KYTC DISTRICT 5 MEMBERS PRESENT FOR RURAL SECONDARY ROAD (RSR) PROGRAM
Planning Section Supervisor, Tom Hall was the speaker. Others present were Andrew Mitchell, Blake Nelson, Matt Bullock and Larry Chaney. The subject is the RSR Paving Program.

There are 72.142 miles of RSR in Bullitt County. There is \$726,119 available The roads for this year is Kings Church Road at \$ 265,956, 3.29 miles, Beech Grove Road at \$ 236,362, 3.27 miles & Horse Fly Hollow Road a \$ 223,800 plus a \$18,000 overage, but KYTC is OK with that. 3.80 miles.

KYTC would like to get the RSR Resolution approved.

On motion of Esq. Logsdon, seconded by Esq. Johnson, with Fiscal Court having concurred, the Rural Secondary Road Resolution to accept the Rural Secondary Road Agreement is approved as presented.

The aim is to reduce recidivism and improve mental health outcomes and enhance public safety. There are five Mental Health Courts in Ky. University Peace Hospital is involved in the program as well.

Esq. Sanders – Happy with the success of the tire reclamation program recently held.


ADJOURNMENT

On motion of Esq. Sanders, seconded by Esq. Johnson, with Fiscal Court having concurred, the motion to adjourn was accepted.


