MINUTES APPROVED

SPEAKER TALL GRASS HEALTH HAZARD

Richard Steelberg spoke to the Court regarding his violation he received regarding his residence. He stated that he is growing a Kentucky Native Plant Area in his yard and he is asking the Court to look into this Nuisance Ordinance regarding his property. The current ordinance does not allow land owners like him, to choose his property to create spaces different from the norm. The Kentucky Native Plant area increased habitat pollinators and decreases the carbon footprint in the area. The Judge stated that they will look into the Ordinance regarding the Tall Grass Health Hazard.

SPEAKER MARK12 MINISTRY

Perry Cooke presented the Court with the obituary for Jason Adcock. He was a homeless man in the area that was struck by train and killed. He was born and raised in Bullitt County and had mental health and addiction problems he was facing. He stated that he met him last winter at their White Flag Shelter, but Mark12 was unequipped to help him. He wanted the Court to beware of the homeless problem and put a name and face to the young man who was killed. Mark12 Ministry will not have a White Flag Shelter this year and is worried about what will happen to the homeless in these winter months.

SPEAKER NUISANCE ORDINANCE

Rebecca Truman spoke in support of Richard Steelberg's idea for Native Plant Sanctuaries. She stated that the Nuisance Ordinance puts limitations on landowners when they are wanting to go from turf grass to pollinator gardens. It does not look the most appealing in the growing stage, but it takes time to create these gardens. She stated that there are programs in the County that support the growth of such gardens, but then you receive violations and substantial consequences for this tall grass. This type of garden is strategic and purposeful for the environment. Discussion was had amongst the Court, Rebecca Truman, County Attorney Tammy Baker, and Code Enforcement Director Christie Royalty-Orr. They will look into the Ordinance regarding the Tall Grass Health Hazard, but the other complaints regarding the property are still in violation.

TAX RATE

David Littlejohn, from the Bullitt County Exension Agency, presented the tax rate for 2023. The Real Property rate has been lowered to .90%, and the Personal Property remains at .91%, and the Motor Vehicle Tax is 1.03%. He stated that the Board is hiring an architect to expand the office with demo kitchens, additional office spaces, and extended staffing. Magistrate Sanders asked about the Equine Services. David Littlejohn stated that they have an arena to utilize but must have certified livestock volunteers to run an Equine 4H Program. But they currently have specialists to help with Equine advice and information.

PRESENTATIONS
KIPDA PARTNERSHIP IMPACT REPORT

Chief Financial Officer, Keith Griffee, gave an update to the Court regarding KIPDA. He stated that they just had their annual meeting and Judge Summers, and himself are voting members on the KIPDA Board. He also congratulated Judge Summers on being elected Chairman of the KIPDA Board as Treasurer. He is happy with the progress they are making within KIPDA and the progress they are making within the County. They have aided in Utility Assistance, Counseling Services, Shepherdsville Wastewater Treatment Plant, Cleaner Water Program Grants, Lebanon Junction Flood Pumping Station, and more. We, as the County, did not utilize all their programs in the past, but are now working to utilize this growth. They have a stronger force in KIPDA now and a better relationship with District Five. He also wanted to congratulate the County on receiving the Second Place Kentucky-Indiana Excellence Award for the turning lanes by Bullitt East High School.
