SPEAKER BROOKS HILL ROAD

James Franke spoke to the Court regarding a strong odor that is filling the air on Brooks Hill Road. He stated that the residents across the street from him, in a residential area, are burning animals. This happened many years ago, and got stopped by the County, but has recently started back up again. He does not believe this is allowed in a residential area where people live and have to smell this odor daily. He cannot enjoy his serene oasis he has lived at for 18 years because of the stench. He has called the Fire

Department as well as the Health Department and they are each saying they cant do anything about this issue, so he has since reached out to the Environmental Protection Agency. Judge Summers stated that he was unaware of this issue but will speak with the Fire Department, Health Department, and the Solid Waste Coordinator to see what can be done.

SPEAKER BROOKS HILL ROAD

Chris Meyers, owner of Brooks Hill Winery, expressed his concerns over the strong odor that is hurting his business. He stated that guests leave when they start up a burn pile, and they have to close up shop because the stench is so bad. He stated that there is ash residue on their grapes, and it is negatively affecting their business. He does not believe they will be able to stay in business if this animal burning continues. Judge Summers stated that they will look into this issue and the County has the option for dead animal disposal.

SPEAKER LIONESS CLUB MARYVILLE POOL

Trisha Moats, President of the Lioness Club in Mount Washington, wanted to invite everyone to their upcoming events. They are having their annual Chili Cookoff on October 26th at 4:30 p.m. She stated that this is one of their largest fundraisers of the year, and proceeds goes toward the Giving Star Tree to help children with Christmas. They contribute to many organizations and families in need. The Lioness Club is a great network of people that want to help with County as they can and are always looking for more members. She also wanted to ask for an update on the Maryville Pool. She stated that it is an ideal location for families to walk during the summer days, and a great thing for our community.

SPEAKER
ANIMAL CONTROL

Jenn and Charlie Meador spoke over their concerns of the influx of animals being dropped off in Brooks. They live off Brooks Schoolhouse Road and all the residents have five plus acres, and animals are constantly getting dumped on their property. They recently had an incident where a small dog was caught in the Wild Game Trap and had to be removed and he had to report the incident. He wanted some clarity on the new Animal Control Ordinance and why the Conservation and Agricultural Exemption must remain. They also questioned why the Bullitt County Animal Control does not have the authority to issue a citation. They have to reach out to Law Enforcement or turn over evidence to the County Attorney for processing. Discussion was had amongst members of the Court, Sheriff Sholar, and the Meador's to see what the logistics are for Animal Control issuing a citation. County Attorney Tammy Baker stated that the new Ordinance will prohibit animals from leaving your land and onto another's property. But your animals may roam on your own land.

EMERGENCY MEDICAL SERVICES TIME ACCRUAL FOR STREET PERSONNEL

Assistant Director Rebekah Osman and Human Resource Director Janice Deweese spoke to the Court regarding some time accrual changes they are asking the Court for. The EMS Department is having a hard time retaining and recruiting employees and are looking at ways to boost morale in the Department. They believe that changing their vacation, holiday, sick, and bereavement time accrual process could be beneficial since they work 12-hour shift, and only collecting time in 8-hour increments. They are asking the Court for the following:

- 1)EMS full time or part time employees working on a holiday 1.5x their hourly rate of pay or receive 12 hours of holiday pay for each holiday,
- 2)Allow employees to be paid 12 hours a day for vacation or sick, regardless if that employee works overtime since this will would be counted as hours worked,
- 3) Offer a different vacation and sick accrual schedule including years of service 0-4 years would accrue 12 hours a month, 5-9 years would accrue 14 hours a month, 10-14 years would accrue 16 hours a month, and 15+ years would accrue 18 hours a month, and
- 4) Allow all EMS employees three days of funeral leave at 12 hours per day.

Discussion was had amongst the Court regarding this change and would like to see a projection of additional fees needed and would like to push this back to the next Fiscal Court Meeting on September 17, 2024.

ORDINANCE 24-22; FIRST READING AMENDING 17-11 AND 24-11 CONTROL OF ANIMALS

County Attorney Tammy Baker gave the First Reading of Ordinance 24-22, an Ordinance amending Ordinance 17-11 and 24-11 relating to the Control of Animals within Bullitt County, Kentucky. The second reading will be held at the next Fiscal Court meeting held on September 17, 2024.

SCHINIAIC

Section 3(c) is amended as follows:

KENNEL LICENSE. Any entity, whether public, private, or charitable, involved in the boarding, breeding, sale, rehoming, or display of animals shall apply for the purchase of a kennel license. Entities with multiple locations must apply to license each location separately. Any entity or owner with more than nine (9) dogs shall be deemed a kennel and shall be required to obtain a kennel license. A kennel license shall in addition to, as opposed to a replacement of, a conditional use permit as issued by Bullitt County Planning and Zoning. Veterinary hospitals, municipal county animal control facilities, and government operated zoological gardens shall be exempt from this provision.

Section 8 is amended as follows:

It shall be unlawful for any owner to fail to exercise proper care and control of his or her animal(s) to prevent them from becoming a public nuisance. Excessive, continuous or untimely barking, molesting passersby, chasing vehicles, habitually attacking in such manner as to damage property, and being permitted to run at large on private property or unrestrained on public property shall be deemed a nuisance.

Given second reading, voted upon and passed at a Regular Meeting of the Bullitt County Fiscal Court on this 17th day of September, 2024.
