NOW, THEREFORE, BE IT RESOLVED that there is hereby levied a special ad valorum tax upon all property a bject to taxation in BULLITT Courty, Kentucky as provided by KRS 212.753 at the rate of 2.4 conts per \$100 of the asserted valuation of all real property and at the inte of 2.4 conts per \$100 of the asserted valuation of all personal property; and at the rate of 2.4 conts per \$100 of the asserted valuation of all motor vehicles in BULLITT County as of January 1, 2025. The motor vehicle tax rate will be applicable to calendar year beginning January 1, 2026.
